4.1 Description of necessary measures:

SECTION 5: FIRE-FIGHTING MEASURES

5.1 Suitable (and unsuitable) extinguishing media:

Product is non-flammable under normal conditions of storage, manipulation and use, but the product contains flammable substances. Isolate leaks provided that there is no additional risk for the people performing this task. Evacuate the area and keep out those without protection.
